AUDIT COMMITTEE:

Mr. Morley: We are reviewing adding a Chair to the Audit Committee which in the past has been the Finance Committee Chair. I will probably appoint Ms. Vaughn as Audit Committee Chair.

COUNCIL/ COMMITTEE REPORTS:

Mr. Morley: We did have one Committee meeting – the Finance Committee. Ms. Vaughn, would you like to report on the meeting?

FINANCE COMMITTEE – Ms. Vaughn

Ms. Vaughn: We had our first Finance Committee Meeting on January 17th with all members of the Committee present as well as the rest of Council. In attendance from the Administration were Mayor Andrzejewski, Finance Director Slocum, Police Chief Reik and CBO Stigalt. We discussed the procedure we will be following during Finance Committee meetings to review budgets. It was determined that we will be meeting probably every two weeks during this critical situation to keep a close eye on the revenues and expenses and we

will be working on the 2012 budget probably initially on January 31st or shortly thereafter. We then moved on to discussion of an amendment to City Ordinance Section 155.01 regarding the part-time Court officer's salary. After discussion the Committee recommended this be moved forward and it appears on the evening's agenda as Legislation No. 01-24-(01). We had also discussed an amendment to Ordinance Section 1301 "Permits and Fees" regarding the commercial plumbing fees and permits. After discussion Mr. Stigalt met with our Council Clerk to clarify some issues and Council recommended it be moved forward and it appears on the evening's meeting as Legislation No. 01-24-(02). Under miscellaneous we had a discussion on garbage bids that went out. We also talked about the Commissioner's sales tax increase which we were not very comfortable with. This concludes my report and I am open for questions.

EASTLAKE CITIZENS' TASK FORCE

Mr. Morley: Mr. Hoefle and I met with the Eastlake Citizens' Task Force last night.

Mr. Hoefle: We had sent out letters to 13 residents and met last night. Eight residents attended the meeting – which was a good turnout. One individual could not make it but said he was still committed to it. Mr. Morley and I – and Mr. Matheke who was in attendance – provided a copy of what Willoughby had done a few years back and provided a brief introduction. We asked them to produce something like Willoughby's. We then left them to conduct the meeting on their own. They will have access to all the Directors for any information they may need. It was a good turnout. I was informed that Mr. Kim Evers will be the Chairman and Ms. April Braun was appointed secretary.

Mr. Evers: Our meeting is the first Wednesday in February at 6:30 p.m. (as Mr. Evers was speaking from the audience his comments could not be clearly transcribed)

Mr. Morley: It was explained to the Task Force that no one from Council or the Administration will attend the meetings – only if requested to do so by the Task Force. We will be providing a memo with all the names on the Task Force in case they ask the Directors a question. We are hoping whatever questions they may have will be able to be answered.

Mr. Klammer: Could you have the secretary of the Task Force contact me before the next meeting so I can determine if they have to provide public notice?

PRESENTATION BY THE LAKE COUNTY METROPARKS

A presentation was provided by a representative of the Lake County Metroparks on the proposed deer culling on Metropark lands.

MAYOR/SAFETY DIRECTOR - Ted Andrzejewski

Mr. Slocum: Last June Council adopted an ordinance for the City to participate in the purchase of the backbone equipment. When that was passed we signed the agreement and sent it to the County. The County came back to us last week and had changed their "Exhibit A" as it related to other participants and not us. The amounts from us remain the same and the contracts remain the same. They asked me to sign it and I reviewed it with the Law Director and am reporting to you that I did sign it and I provided the Clerk with a copy of what we did sign. I am working on the budget and will have it out by next week at the latest. I am open for questions.

CITY ENGINEER - Tom Gwydir

Mr. Gwydir: I have nothing to report and am open for questions.

CHIEF BUILDING OFFICIAL - John Stigalt

Mr. Stigalt: Thank you for passing our ordinance for commercial plumbing fees. We will begin February 1st. This will bring income to the City and better service to our residents and commercial businesses. We are basically doing housework – cleaning and getting things ready for that day. We still have permits coming in for interior alterations and a couple of demo permits for homes. I am open for questions.

<u>POLICE CHIEF – Larry Reik</u> Chief Reik: I have nothing else to report.

FIRE CHIEF – Ted Whittington

Fire Chief Whittington: I know he is not going to mention it but if you are following the newspaper I think the Police Department did a pretty bang up job on the murder for hire – they got a conviction and Chief Reik and his staff were heavily involved. It may not be something we want to hang our hats on but as far as police work goes it is a testament to these guys. This concludes my report and I am open for questions.

Mr. Morley: I was lucky enough to be with the Chief the day of the arrest. They did do a great job. I have told them that in the past - all that were involved that day - I am proud. And everything I am seeing on the police facebook page is always interesting. You guys have your hands full and we appreciate everything you do.
