The Regular Meeting of the Eastlake City Council was held at Eastlake City Hall, 35150 Lakeshore Boulevard. The Meeting was called to order by Council President Mr. Morley at approximately 7:12 p.m.

Please pass that onto the guys. That concludes my report and I am open for questions.

Mr. Knuchel: The Finance Committee has not met since our last regularly scheduled Council meeting, therefore, I have no formal report. SERVICE/UTILITIES COMMITTEE - Ms. DePledge

Ms. DePledge: The Service/Utilities Committee met on March 1st at 6:06 p.m. Members of the Committee in attendance were Mr. Lajeunesse and me. Mr. Hoefle was absent and excused. Also attending from Council were Ms. Vaughn, Mr. Knuchel, Mr. D'Ambrosio, and Council President Morley. In attendance from the Administration was Mayor Andrzejewski. There were two items on the agenda with the first being the purchase of a replacement bucket for the 1997 Case loader. It was decided that as there was only one provider for this it was not necessary to go out for bids and that this item would be added to the evening's agenda. The other item on the agenda was a quit claim deed for the .1298 acres to Chagrin Park, LLC for which Willoughby requested to transfer some property. RECOGNITION OF THE PUBLIC

Mr. Morley recognized the public input at this time; he reminded the speakers that there is a 3-minute limit for their comments; all comments are to be directed to the Chair and not include any personalities or individuals.

Doris Dayner, 839 Charles Street, Willowick, OH

Ms. Dayner: I am here after 20 years of constant flooding from Eastlake – the apartments. When I bought the place there was land and only trees. I come home in the 80's and behind me was a five foot high pile of dirt and after that a parking lot and dumpsters. The last 20 years I have had to refinance my house over and over. We have pictures from 2004 that the City had taken of the flooding. In 2006 I had another one so devastating FEMA loaned me money because I am constantly flooded. I am paying them \$30,000. I came home Sunday night and was flooded again. Everything I paid \$30,000 for is gone. The Fire Department came and shut down the heat and water heater. I had no heat. If it was not for my relatives I would not have had a furnace because by now I am depleted and nothing has been done. I have gone to the City Inspector who came out and turned me in for bees. Bees were there because of the water. So, my inspector came and it cost me \$600 for the person to come out and spray. By now, if you want to come and look, it is devastating. I cannot express to you how horrible it is. I am out of funds. The house has been refinanced over and over to pay for the damage and now I owe FEMA and it is gone again. The lay of the land has changed and the Fire Department was so upset – they said to take pictures. But I could not because it was impossible. If you want to inquire from them and come and see the devastation of property.

Mr. Morley: Everyone you are talking about – have you talked to the City of Willowick about this?

Ms. Dayner: I went to Eastlake. Willowick just came and took pictures. I had to have the Fire Department the last time.

Mr. Morley: I am not trying to push it away but you are saying you are a Willowick resident – have you contacted anyone in Willowick?

Ms. Dayner: They can't do anything because they say it is Eastlake. It is the apartment.

Mr. Morley: We can have our Assistant Service Director contact someone in Willowick and talk to them. Have they come out at all – their inspectors?

Ms. Dayner: Yes, they said it is the lay of the land – they raised it up. You cannot change the lay of the land. When Willowick built apartments they left it level. Eastlake allowed them to change the lay of the land and we are the ones constantly being flooded because I am the one by the parking lot and the dumpsters.

Mr. Morley: Are they the Bayshore Apartments?

Ms. Dayner: No.

Mr. Knuchel: It is the Clearwater.

Mr. Morley: We can have our Service Director contact Willowick's Service Director – please provide him with your name and phone number so he can get back to you regarding what he finds out. We have no issue in finding out that for you but we will have to talk to Willowick to see if there are any issues there.

Ms. Dayner: They said it was Eastlake – that they could not do anything.

Mr. Morley: I understand that but if the two Departments can talk maybe we can find a solution for you.

Ms. Dayner: I pray because I had one in 2004 and 2006 and now this in 2011. No one would put up with that. If I did not have Jesus Christ I wouldn't. Thank you.

There was no one else who wished to speak.

<u>ADMINISTRATIVE REPORTS:</u>

MAYOR/SAFETY DIRECTOR – Ted Andrzejewski

Mayor Andrzejewski: The tickets for the Captains Eastlake Appreciation Day are \$1.00. I know the Gazette said \$2.00 but it should be \$1.00. They will go on sale Monday and are open to any Eastlake resident for a limit of 6. If someone comes in and shows us they have five kids we will give them the extra tickets. But, you have to limit it somewhere. The only thing we ask is they bring in some proof that they are an Eastlake resident – like a driver's license or utility bill. You would not believe the people from other cities who come in. As an example - my mom works for Willoughby/Eastlake schools – and I ask where they live – and they say Willoughby –my sewers are through Eastlake. We are not trying to be hard. It is something nice the Captains are doing to show appreciation to the Eastlake residents because it is our tax dollars that help pay for the stadium. Raffle tickets for the City loge are also available now. We have already had 12 or so people come in. As you know we raffle off 4 tickets a week for three families for every game to use the City loge. We do not provide food but it is a nice way to give people who don't normally get to see a game from a loge the opportunity to experience it. Last Sunday I had the honor to go to Berea, Ohio and receive

an award – Eastlake was named the most patriotic City on the east side of Cleveland. Berea was named the most patriotic City on the west side. Both for similar reasons. Our Blvd. of Flags and the 9-11 Memorial and more importantly for the Memorial Day, Labor Day, Veterans Day, and Pearl Harbor Day ceremonies. I wanted to thank Jim and Joe Strand and the Flag Committee and also Jim Barkley. I don't know what we are going to do when Jim leaves us – he is the guy who arranges all the different ceremonies. There is a nice article on the website. We got a nice plaque and received recognition from Congressman Kucinich and Congressman LaTourette. We also have a flag that was flown over the Capital. It was a nice honor. If any of you have not visited yet you may want to stop by the room that is used by the Historical Society. They have really done a nice job. There are shelves with historical stuff on display. For me the most interesting thing is to look through the old newspaper articles and see some of the prices of things and some of the people who ran and worked for the City and County years ago. They have done a nice job and are open on Thursdays. I know they are going to keep expanding it. Again, thanks to them - it is done by a volunteer Committee. Last but not least our moderator Chuck Price is doing a good job and getting a lot of calls for the advertising we are going to do on Channel 12. We are going to raise some money with all of it to go to buy used equipment for Channel 12 and Channel 99. Some of the stuff we have now is pieced together and about every other week something decides to break. Hopefully within the next year we can raise \$5,000 – that is our goal – it will not come out of the City budget. Same as everyone else – everyone did a good job in the flood. We know some of you would be there if you could but you have jobs you have to attend to and we understand that. This concludes my report and I am open for questions.

Mr. Morley: Thanks for reminding me. For whatever reason my Gazette article did not get published. Mr. D'Ambrosio and I had the honor of going to the Girl Scouts Gold Award – which is an award comparable to the Boy Scout's Eagle Award. One of the recipients was Mr. Rydziniski's daughter, Emily, and Megan Hobart. I knew the Mayor could not be there but we were there. It was a good ceremony and these two girls were honored as Gold Award recipients. I would like to congratulate them again. I was lucky enough to be riding around with the Police and Fire Chiefs. I talked with Mr. Ramski and was out with Mr. D'Ambrosio on Edwards. I saw Mr. Knuchel. The people who were off work could be out there during the flooding. It was not fun to watch and the lady that was just here and the houses that were flooded – it was not good and caused a lot of frustration. But, we will continue to try to take care of the flooding issues as they come. Ms. Vaughn and I also went to some houses on East 331st Street and met with six households about the flooding that happened there and we have talked with Mr. Ramski about trying to get some fixes there. The flooding is unfortunate but with the crazy weather we have had this year. I am amazed how much the Police and Fire Departments know about the river. I have learned things about the river from Mr. Ramski that I never knew. Good work by everyone in all Departments.

Mr. D'Ambrosio: Mayor, at the last Council meeting you mentioned there were some problems with the Captains.

Mayor Andrzejewski: All resolved. Thank you for bringing that up. Unfortunately sometimes you have to play hard ball. But, we got our money for the CRIF fund and received the money for the reimbursement of the Fire Marshall.

Mr. Slocum: Those were the two issues. We had a meeting with the Captains and the Fire Chief and we were actually able to work out all issues. Just sit down and have an exchange. Things were paid last week on the reimbursement on the fire and a couple of weeks earlier with the CRIF fund. We are totally squared with them.

Mr. D'Ambrosio: I saw the memo and knew it was mentioned last Council meeting.

Mayor Andrzejewski: It is sad you have to do that but that money is owed to the City of Eastlake and the people. We got it all.

There were no further questions of Mayor Andrzejewski.

LAW DIRECTOR - Randy Klammer

Mr. Klammer: One of the interesting things to come out of the flood was I was brushing my teeth and both of my kids came running to alert me that the Mayor was on T.V. So, you can take that as a sign that you are at least recognizable to my five year old and eight year old.

Mayor Andrzejewski: They are great, great kids.

Mr. Klammer: It should also caution me that I should get better security settings for the T.V. I am open for questions.

Mayor Andrzejewski: I don't publicize this too much but we also got flooding – me and my neighbor. We were able to stop most of the water but we were up at 4:00 a.m. plugging up drains and mopping up. We know what it is like. As that lady pointed out about the FEMA loan – I have one of those loans that I have five years to pay on. In 2006 we got completely wiped out. We are not without empathy towards the people who get flooded.

There were no questions of Mr. Klammer.

FINANCE DIRECTOR – Mike Slocum

Mr. Slocum: I was out last week so I do not have anything official to report. We will be going over the budget tomorrow. I am open for questions.

There were no further questions of Mr. Slocum.

<u>SERVICE DIRECTOR – Mike Semik</u>

Mr. Morley: Mr. Semik is absent and excused so I invited Mr. Ramski – I thought there would be residents here from the Edwards area but no one came. I appreciate you coming.

Mr. Ramski: I will pass the kind words onto the Service Department that you people expressed. Thank you very much.

POLICE CHIEF – Larry Reik

Chief Reik: Officer Isabella did a fraud investigation for a lady about 1½ years ago and it impacted her so much that she nominated him for American's Most Wanted MVP. They have a web site listing the officers and the criteria why the officers were nominated. If he would win there would be recognition through the television show. I also received

notification yesterday that a dispatcher was put in for an award. Two years ago she assisted with a choking baby in the Valley Creek area. She kept the mother very calm who was obviously frantic. She was nominated for an award – the State Dispatch Award which they present every two years. She does not work with us anymore. She is out in Ashtabula. That will be coming up in April. I am open for questions.
