# **COMMUNICATIONS & PETITIONS**

Conditional Use Permit referrals were received from the Planning Commission for China Buffet Yu, Inc., 33550 Vine Street, Eastlake and Vine Properties Co. Partnership, 34001 Vine Street, Eastlake. These were referred to Planning Committee.

A bid recommendation was received from the Administration for the Erieview Drive Reconstruction Project. Mr. Morley explained that this was discussed in Council-as-a-Whole Committee and will be added to the evening's agenda as Legislation No. 06-25-(05).

#### Additional Comments:

Mr. Morley: Per discussion at the Council-as-a-Whole meeting I am referring the email received from C.T. Consultant's regarding the ideas for the repairs to Stevens Blvd. west of S.R. 91 to Service/Utilities Committee.

Ms. Vaughn: I know Council will be on break but I am scheduling a Finance Committee meeting on July 16<sup>th</sup> as at that point in time we will have the six month breakdown of all our expenses. We cannot get it before that time and I feel it is important to look at the first six months of this year. I am also respectfully requesting the Directors and Chiefs to be there as well.

# Ordinance Committee – Mr. Hoefle, Mr. D'Ambrosio, Co-Chairs

Mr. Hoefle: The Ordinance Committee met Tuesday, June 18<sup>th</sup> with all members of the Committee and Council present except for Mr. Licht who was absent and excused. In attendance from the Administration were Mayor Andrzejewski and Finance Director Slocum. We discussed the Commissions and Boards – Mr. Slocum, do you have any comments?

Mr. Slocum: The purpose of the amendments is due to the recent IRS audit. We had to put all Board and Commission members who receive a \$50 monthly stipend on the actual payroll. We had several different Board members request to not get paid. So, this gives us the ability to reimburse them for expenses and keep them off the payroll. My guess is there will not be that much expense actually spent but if there is then there is – we will take care of it.

# Ted Beres, 36706 Lakehurst Drive, Eastlake

Mr. Beres: Saturday my wife wanted me to drive her to Shoregate before the banks closed at 2:00 p.m. On the way back home we got stopped by the barricade on S.R. 91 and Lakeshore Blvd. for the parade. So, we like many others had to turn around and go the other way. I am familiar with the area and had no problems finding an alternate route. But some people may have been new to the area and may have been going to the Riverfest but they had to turn back. When you see other cities in the news they usually pick a main street and do not zigzag through their community. The old WalMart has a large, empty parking lot – maybe you could assemble there and go down Vine Street or if you are going to maintain the same route maybe you could do what they do for funerals – have a police car go in advance of the parade and block off the intersection until everyone goes through and then go on down to the next intersection and block it. I think there are some ways we could avoid the inconvenience to the people who are traveling through our community.

# **ADMINISTRATIVE REPORTS:**

# MAYOR/SAFETY DIRECTOR – Ted Andrzejewski

Mayor Andrzejewski: Those of you who attended the festival know we had some nice crowds and everyone seemed to enjoy themselves – there were more rides this year. It turned

out nice – a little hot. The parade was good and we had about 30 participants – the kids like the candy. These are not promises and these are not set in stone – but I am working on a couple of things with WalMart. One is to try to get the cut through back between where the old WalMart was and the new WalMart is now. The hang up seems to be with the owner of the plaza. WalMart is all for it. The grocery store who you would think may object to us is actually for it. For whatever reason the owner of the plaza is not and I am trying to arrange a meeting between WalMart and myself and the owner of the plaza to see if we can work something out. Also, I am going to talk to the WalMart people about the two entrances on Vine Street to see if we can get left and right turns. The other thing I am looking at is to try to get ODOT to allow us to put a no right turn on red on East 337<sup>th</sup> Street and Vine Street. It would allow people turning left into WalMart more time. Right now if the light is red on East 337<sup>th</sup> Street and it is okay to turn right on red people just keep turning and there is no space for the people turning left. You will have growing pains. I listen to all comments and will try to pursue things. It is not a promise – do not tell people that – I have to have consensus from all parties involved. I am aware of some of the calls and difficulties and when all this is over I know WalMart will add a tremendous increase. I have talked with other businesses and they have told us they have had increased business because of WalMart. I have to comment on the parade route. I have been Mayor for 9 years and have done the parade over the same locations and route for 9 years. I can tell you in all honesty I have never, never had a complaint about the route. The kids know that route – there are residential neighborhoods there – there are houses there and that is what they prefer. I would hate to tie up Route 91 and Vine Street for an hour or two for a parade. Can you imagine if we started at WalMart all the businesses that would be shut down for about an hour for the parade to go through and then coming up S.R. 91 – we would not have access to Vine Street, Stevens, Glen or Beachpark. We do shut down Roberts a little bit but that is a small portion of S.R.91. I appreciate all comments and I will listen to all comments but the parade route is fine the way it is and I would not want to tie up our businesses on Vine Street. I am open for questions.

Mr. Morley: Mayor, we have received some calls from people on East 337<sup>th</sup> Street – one resident who lives across from the bank who has said since the bank opened that driveway she has a lot of headlights through her home. I know she spoke with you and Mr. D'Ambrosio. I have not had that many calls – mainly about the tie-ups on East 337<sup>th</sup> Street.

Mayor Andrzejewski: Two ladies were not aware Vine Street had two entrances – they thought the only access was on East  $337^{th}$  Street. I think it will all work out – it will just require some fine tuning.

There were no further questions of Mayor Andrzejewski.

#### LAW DIRECTOR – Randy Klammer

Mr. Klammer: The pawn shop thing is still moving forward. We had a hearing the other day. The Mayor noticed something in the agreement we will address and it should work itself out. I should have a draft for you. I followed up with the email sent some time ago to you, Mrs. Quinn-Hopkins, regarding the ECDC. Whenever you wish to follow-up please let me know. I am open for questions.

#### FINANCE DIRECTOR – Mike Slocum

Mr. Slocum: I am not sure if Council is aware but the Visitor's Bureau is vacating their offices at the stadium. They have decided to relocate to Painesville. I think it is consistent with the grant we had been receiving which expired this year – as that is gone – they are gone. They never entertained any thought of negotiation in retaining the lease. They are moving.

Mr. D'Ambrosio: I know there was another business that left the City with about 100 employees?

Mr. Slocum: Right.

Mr. D'Ambrosio: Is there a way you can show who much revenue will be lost – I know there are tax issues you have to be careful with – so we have an idea of how much revenue reduction there will be?

Mr. Slocum: If you read the paper I think Euclid reported they are bringing about \$5.5 million in jobs there – they are not taking \$5.5 million from us – there is an expansion. But it will sting. I am limited as to what I can report. But, that loss will sting. I do not know when they are leaving or what their timetable is. It will not help.
