Mayor Morley stated he has a meeting with First Energy and mayors from surrounding cities to land wanting to be purchased. Mayor Morley stated they have scheduled the first

meeting for the Vine Street Corridor on February 4th with the other mayors, Laketran, and stated he will have more after that meeting.

Chief Reik stated he has two new officers who have finished training. He also discussed how they will have three more officers and two police dogs training by the summer.
