- INDOOR & OUTDOOR SWIMMING POOLS, INCLUDING AN IN-GROUND, ABOVE GROUND, ON-GROUND POOL, HOT TUB OR SPA SHALL BE PROVIDED WITH A BARRIER
- EVERY SWIMMING POOL SHALL BE ENCLOSED BY A FENCE OR BARRIER AT LEAST FORTY-EIGHT (48) INCHES IN HEIGHT AND CONSTRUCTED TO PREVENT ACCESS TO SUCH POOL BY SMALL CHILDREN
- WHERE AN ABOVE GROUND POOL STRUCTURE IS USED AS A BARRIER OR WHERE THE BARRIER IS MOUNTED ON THE TOP OF THE POOL
 STRUCTURE, AND THE MEANS OF ACCESS TO THE POOL IS A LADDER OR STEPS, THE LADDER OR STEPS SHALL BE CAPABLE OF BEING

- WHERE ACCESS FROM A DWELLING UNIT TO A POOL IS AVAILABLE, AN APPROVED FENCE WITH A LOCKABLE GATE SHALL BE PROVIDED
