#### ADMINISTRATIVE REPORTS:

#### MAYOR / SAFETY DIRECTOR - Dennis Morley

Mayor Morley stated that thanked council for passing the fire negotiation. He stated that he has a Tuesday/Thursday meeting with the health district. He stated they continued to talk about COVID-19 and what they are doing to continue to keep everyone safe. He said they should know in a couple weeks whether or not they will be opening the pool for the summer. He said if they do not open the pool for the summer they will be putting a new roof on the pool instead. He said they talked about possibly having a day camp at EPAL and having the camp go to the pool but this is still under discussion. He then stated that himself and Chief Whittington are going down to inspect the new firetrucks which should be arriving sometime in June. He said City Hall still remains closed and said it is working well how they have it set up now and they have put glass in finance and building. He said there is still no decision on when the Senior Center will reopen. He stated he spoke with the person who runs the car shows and that they are postponed until further notice. He said that two summer help started and that should help them catch up on grass cutting throughout the city. He said they still don't know if they Captains will play. He said he doesn't imagine they will play. He said the captains started curbside pickup on Wednesdays. He said they may try and play old games to try and get some sort of revenue because they are taking a large hit. He said the Miracle League has canceled their season which is a large blow to them but may play come fall for that season. Mayor Morley said Little League baseball may not play but it is still in question. He said that the farmers market is going to be at the captains parking lot on Wednesdays from 3:00 to 7:00 and that vendors know they have to follow CDC guidelines on social distancing, wearing masks, and cleaning. He said June 7th at EPAL will have a Father's Day Frolic. He said he continues every day to try stay on the same page as everyone on social distancing and mass gatherings. He said he thinks that if nothing happens by the end of June everything will be canceled for the rest of the summer. He said that the directors are doing a very good job at tracking their costs during the pandemic. Mayor Morley said the auditors are still working on the 18-19 financials and that Carol-Ann Schindel is working on possibly refinancing bonds on the stadium. He said he is trying to shave 5 years off of their payment to coincide with the Captains Lease which is up in 2025 and their goal is to refinance the bonds to save money. He stated that at this point in time we've lost about \$177,000.00 in revenue from income tax.
